At the outset, the Chairman, Senate welcomed the members and the special invitees to the forty first meeting of the Senate. Thereafter, the agenda items of the day were taken up.

Item No. 1: Confirmation of Minutes of the XXXVIIIth, XXXIXth & XLth Senate Meetings held on 17.05.2024, 07.06.2024 & 28.06.2024 respectively.

The Thirty-Eighth meeting of the Senate of the Institute was held on 17.05.2024 in the Conference Room of the Institute through hybrid mode (online and offline) and the Thirty-Nineth and Fortieth meeting of Senate of the Institute were held on 07.06.2024 and 28.06.2024 respectively through item by circulation mode. The minutes of all the meetings were circulated amongst the Senate members for their comments/observations.

R1/SENATE-XLI/24: The Senate **Resolved to Confirm** the minutes of the XXXVIIIth, XXXIXth & XLth Senate Meetings.

Item No. 2: Action Taken Report on the decisions of the XXXVIIIth, XXXIXth & XLth Meetings of the Senate

The actions taken on the decisions of the XXXVIIIth, XXXIXth & XLth Meetings of the Senate were presented during the meeting and the Senate members noted the actions taken by the Institute.

R2/SENATE-XLI/24: The Senate **acknowledged** and **approved** the actions taken on the resolutions of the XXXVIIIth, XXXIXth & XLth Meetings Senate Meeting.

Items for Approval

Item No. 3: Revised curriculum and syllabi for Undergraduate (UG) programme in line with the NEP 2020.

The Senate was informed about the work progress of the Institute regarding the implementation of the NEP 2020 guidelines wherein the following points were presented:-

1. Constitution of the departmental level Board of Studies (BoS).
2. Introduction of the Minor Degree in Sports Engineering.
3. Introduction of Micro Credit Courses (NCC/NSS/YOGA/Mental Health wellbeing etc.)
4. Implementation of 4th year UG courses under NEP guidelines.
5. Multiple Exits in B.Tech. programme.
6. Implementation of Long-term Internship
7. Online courses (NPTEL/SWAYAM etc.) registration and mapping.
8. Progressive Curriculum and Next-Gen courses

In addition to the above the Senate was informed about the implementation plan. Thereafter, the Engineering and Science departments of the Institute presented the updated curriculum and syllabus for the Undergraduate (UG) programme, aligning with the NEP 2020 guidelines. These revised courses had been duly approved by the Departmental Board of Studies (BoS) and subsequently recommended by the Academic Programme Committee (APC).

The Senate discussed the UG programme curriculum and course syllabus placed as **Annexure 1** in detail with the Deans and HoDs and resolved to approve the courses and curriculum after minor modification in Chemistry and Math Courses.

R3/SENATE-XLI/24: *The Senate Resolved to Approve the revised curriculum and course syllabus for UG programme as presented by all Engineering and Science Departments.*

Item No. 4: Proposed UG Ordinance Amendment in line with NEP 2020.

In line with the implementation of the guidelines of the NEP 2020. The *prima facia* amendments were proposed in the existing UG Ordinance of the Institute.

The list of existing and the proposed amendments in the UG ordinance were placed as **Annexure 2** for discussion.

The Senate had gone through all provisions and suggested some minor changes which have been duly incorporated in Annexure 2.

Item No. 5: Course Codes related to the NEP curriculum.

In continuation to the resolution No. R(3.5)/SENATE-XXXVIII/24, the Senate suggested revisiting the course codes and recommended incorporating code provisions for Minor degree courses and Micro Credit courses. In line with the same, the format for finalization of the new course codes as per the NEP curriculum was discussed in detail and accordingly

a fresh proposal on course codes had been drafted and placed before Senate as **Annexure 3**.

The Senate discussed the matter and considered the course codes scheme as proposed.

Item No. 6: Permission for Ms. Menuvolu Tetseo P21EC008 to stay at IIT Bombay for another 6 months.

The Senate in its 34th Meeting had allowed Ms. Menuvolu Tetseo bearing roll no. P21EC008 for carrying out experimental research work at IIT Bombay for 6 months under INUP program. Subsequently the NoC and user agreement form was signed by the Institute in this regard. Later, on 28.05.2024 Dr. Pradeep Kumar Rathore, Asst. Prof. EC Dept & PhD Supervisor of the above-mentioned scholar has informed that the research work is being carried out at IIT Bombay and requires complete fabrication and testing of CMOS-MEMS integrated cantilevers for low mass sensing applications. This involves the optimization of each single step involved using the fabrication facilities at IIT Bombay. The scholar is performing the experiments as per the availability of materials and facilities at IIT Bombay's fabrication Lab, but unable to get the required results.

In continuation to this, Dr. Rathore has requested to extend the stay of the Scholar till December 2024 for successful completion of the project work. The note sheet submitted by the Dr. P. Rathore along with the other relevant documents were placed as **Annexure 4** for kind reference please.

Following extensive deliberation, the Senate permitted the final extension upto December 2024.

Item No. 7: Request of Mr. Souradeep Bhowmick, TA, ME to issue NoC for PhD Part Time Admission.

The Senate was informed about the application dated 08.05.2024 received from Mr. Souradeep Bhowmick, TA, ME wherein he has requested for permission to pursue PhD Programme (Part Time) in the ME Department offered by the Institute. The application of Mr. Souradeep Bhowmick was recommended for consideration by the HoD, ME and also by Dean(AA).

The advertisement No. NITMGH/AA/Phd-Admission/2023-24/716 dated 27.03.2024 for sponsored (Part Time) and the eligibility criteria for admission into PhD programme was discussed in detailed.

Later, it was noted that the total Regular Work Experience of Mr. Souradeep Bhowmick is 2 years & 5 months as on 31.05.2024.

Application dated 08.05.2024, Institute PhD Advertisement along with all related documents in this regard were placed as **Annexure 5** for kind reference please.

After a detailed deliberation, the Senate has noted: -

1. The Project Experience of Mr. Souradeep Bhowmick is in line of his proposed research work.
2. Mr. Bhowmick has qualified Gate 2 times.

Further it was decided to grant a one-time relaxation to Mr. Souradeep Bhowmick, TA, ME with recommendation to issue him a No Objection Certificate (NOC).

Also to mentor the displaced students, the NIT Meghalaya has nominated the Institute level and Department level point of contact vide order No. NITMGH/AA/Notification/2023-24/902 dated 19.06.2024.
