- The Committee shall carry out the following activities related to transportation requirements of the Institute:-
1. To liaise with the Agency providing the vehicles and buses to NIT Meghalaya from time to time as per order issued to the Agency.
  2. To demand for extra vehicle from the Agency as and when demands are received from the Faculty or Staff for official purposes.
  3. To allocate the vehicles to the faculty or staff on demand as per the requisition received from the concerned officials.
  4. To monitor the allotment and movement of vehicles, buses and ambulance.
  5. To take action for maintenance of the official vehicles and ambulance including their fuel and services and take the imprest money for fuel and maintenance to.
  6. To obtain the approval of the Competent Authority for allotment and maintenance of vehicles, buses and ambulance.
  7. To depute the ambulance for the faculty, staff, students and hostellers on medical emergency.
  8. To renew or award the contract of the Agency as and when required depending upon the satisfactory services of the Agency.
  9. To verify the Log books of all vehicles, buses and ambulance.
  10. To verify the bills received from the Agency and recommend for release of their payment on monthly basis including the extra vehicles hired.

The Committee is constituted with immediate effect and until further orders.
