6. The Quotations would be evaluated for all items together.

7. Award of contract:

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

8. Payment shall be made in Indian Rupees as follows:

**Delivery and Installation - 90% of total cost**

**Satisfactory Acceptance - 10% of total cost**

9. All supplied items are under warranty of **24** months from the date of successful acceptance of items.

1	Measurement of Jet Apparatus	(i) tank (inner diameter 180 - 220 mm and height 300 -350 mm) made of transparent material for observing the experiments (ii) nozzle (9-10 mm diameter) for generating the water jet (iii) jet force can be adjusted via flow rate (iv) at least four different shaped deflectors: flat surface (90deg), oblique surface 45 or 135 deg), semi-circular surface (180 deg), conical surface (135deg) ; additional deflectors will be preferred (v) various weights 0.1 N to 20 N for creating jets (vi) measurement of flow rate and the jet forces via scale (vii) provision for inlet for water supply from laboratory (viii) Dimensions within 1 m3
